Our third-party partners do not collect personally identifiable information about your online activities over time and across third-party websites or online services through your use of the Website.

2. How Santosh Group & its subsidiary companies Uses Your Information: Santosh Group & its subsidiary companies may use your information (a) to provide you with personalized content; (b) to process and respond to inquiries; (c) for the purposes for which you provided the information; (d) to improve the content and navigability of the Website; (e) to alert you to new features, special events, and service offerings; and (f) to enforce the Terms of Use.
